New Business:

#1 Homeowner concerns/issues

Mark and Holly wanted to talk about new law (HB 22-1139) stating HOA cannot enforce parking on the street. Board members agree. A question from the board was, is Mark and Holly's Carpet Cleaning Business being ran out of their home. Holly states they both have offices, and no business is being ran out of home. Lee provided Holly a copy of by laws of no business allowed in home. Board stated can't stop them from parking on public street, Lee stated we are registered with the CCIOA and provided Holly a copy. Board agreed to have all communications via email, however Mark kept bringing past topics up, Mark was asked again to stop bringing up past issues that have already been resolved, and that if he kept this behavior up, he would be asked to leave. Mark kept bringing up he didn't want any HOA board members on his property, and he was told he had to leave. Holly brought up one final issue, that when she sends the board an email, she wants the board to reply all, she stated she adds Mark to the emails, and the board does not reply all. The board stated moving forward, then will reply all. Mark and Holly left the meeting at 6:42 PM

Lee and Jamie will work with Bailey for quotes and steps to make new Woodland Ponds Subdivision website secure (require log in to view finance, member info, any other secure info we don't want to share with public). This cost will be shared with board in future meeting to discuss if we want/need to have our website as secure

#6 Discuss proposed Amendment #4

At 7:12 PM Board went through all 6 proposed amendment #4 changes (see attached). The board discussed each item to make any changes to wording before sending out to homeowners. Lee will type up new proposed wording for all 6 proposed amendment #4 changes.
